## Think expansion at Stansted is a done deal? Think again!

**M**any people think that airport expansion at Stansted is a done deal. That the Government has already made up its mind.

If you're one of them, think again: despite what the aviation industry would like us to believe, no decision has yet been taken.

There is still everything to play for and we must keep up the pressure with the same energy and strength of opposition that have resulted in our campaign having such an impact to date, showing the Government that, never mind the three extra runways which it has proposed for Stansted, we won't accept any.

### THERE'S STILL TIME TO ACT

You may have already written letters opposing the plans for

Stansted but now, more than ever, we need to drive that message home.

The Government has already received far more letters of opposition from the public to its airport expansion proposals than to any previous public consultation in history. When these responses have been digested, the Government will decide what to do and will publish its decisions in a White Paper - expected in December.

Final decisions will be taken by Ministers at Cabinet level in Government and it is known that the force of public opposition has led to major differences of opinion between Whitehall departments and amongst Ministers. It is understood that the Department for Transport has already been forced to retreat considerably from its original proposals - and the debate still has some way to run.

Now is the time to keep up the pressure!

### OUR OBJECTIVE? KEEP STANSTED OUT OF THE WHITE PAPER

It could make all the difference to the outcome if we continue to register our opposition by writing to our MPs to reiterate our concerns – never mind how many letters have already been sent.

This is a very valuable course of action since the size and shape of MP and Ministerial postbags will really influence the outcome of the Air Transport White Paper which will set out Government policy and intentions for the future.

# What would expansion mean?

## ● MUCH MORE NOISE:

Over 70 beautiful rural villages and market towns which characterise the Herts and Essex borders, parts of Suffolk and South Cambridge would be severely affected by gridlocked roads and a sky full of noisy planes stacking, landing and taking off, not only in the day but increasingly at night.

## ● HERITAGE LOSS:

Hundreds of homes would disappear including scores of listed buildings including many thatched cottages and sites of historic interest.

## ● ENVIRONMENTAL DEVASTATION:

Ancient lanes and woodland including Elsenham Wood (a site of special scientific interest) would be concreted over, while the last remaining medieval hunting ground in Europe – Hatfield Forest – would be badly degraded. BAA's proposals for even one extra runway, meanwhile, would involve further land-

take for a new rail link from Elsenham through the airport terminal, crossing Takeley Street, running beside Hatfield Forest then between Hatfield Broad Oak and Hatfield Heath, through Sheering to the main line at Harlow Mill.

## ● INCREASED AIR POLLUTION:

The health of children and the elderly would be particularly compromised by increased pollution levels from both planes and, more especially, the tens of thousands of extra cars that would come to the airport each day. Road traffic and aircraft are also major contributors to global warming – a key issue for future generations.

## ● MAJOR URBANISATION:

Rapidly vanishing countryside would be eaten up for new office, warehousing and other industry serving the airport, not to mention houses for up to 80,000 extra airport workers and their families.

# Even one extra runway is one too many

**T**he Government has put forward plans for a possible three extra runways at Stansted. The reality, however, is that even one more runway would devastate this region's character and result in such major urbanisation that it would become unrecognisable.

Many people, of course, believe that three runways were proposed so that we would be less shocked if just one were actually recommended.

This is why it is so important to fight just as strongly against one more runway as against three. After all, the urbanisation, gridlocked roads, health, quality of life and heritage and environmental impacts of

transforming Stansted into an airport the equivalent size and potentially even bigger than Heathrow today would give rise to major implications for this area.

## WHAT DIFFERENCE HAVE WE ALREADY MADE ?

Stop Stansted Expansion has staged an extremely effective media, lobbying and grassroots campaign to date, acknowledged by many to have been a powerful element in moving thinking away from the inevitability of extra runways and the destruction of the homes, heritage and lives of so many people across south east England simply in the pursuit of

the profitability of the aviation industry.

By gaining valuable extra time for the consultation following our successful legal action at the High Court last November, we have enabled the voices of many powerful allies to be heard by the Government. The House of Commons Transport Committee, for example, has recommended the break up of the BAA monopoly. The Environmental Audit Committee, meanwhile, has made strong recommendations that the aviation industry actually pays for the environmental damage that it causes.

Other powerful voices in the debate, including the Royal Commission on Environmental

## What the Government is proposing

- Adding one, two or even three extra runways to the existing one.
- Increasing capacity from around the current 18 million passengers a year to up to 129 million – or 140 million a year according to BAA's response to the proposals.
- Up to five times the current number of flights, using larger aircraft than ever.
- The transfer of 40% of Heathrow's transatlantic and long haul schedules to Stansted.
- Making Stansted the UK's number one freight airport (much freight is moved at night).

Pollution, Sustainable Development Commission and even the Government's favourite think-tank, the Institute for Public Policy Research, have all voiced their concerns about the extreme damage that will be done if further runways are constructed in

the South East.

East Herts District Council and Essex and Herts County Councils have teamed up to fight the proposals for even one extra runway. Meanwhile, Uttlesford District Council, the planning authority for the airport, has

made clear the overwhelming local opposition to expansion through a vociferous campaign reflecting the 89% of electors who voted 'no' to extra runways in a referendum attracting a bigger turn out (69%) than the last general election.

If we have to gain yet more time by pursuing legal challenges if Stansted does appear in the White Paper, we will not shrink from this course of action which has demonstrated its value over the last year.
